**March 1:** Deadline to contribute to an RRSP, PRPP, or SPP

**May 1, 2023 since April 30 is a Sunday:** Deadline to file and pay your taxes

**June 15:** Deadline to file your taxes if you are self-employed

<b>When</b>	Starts Feb 20. 9AM– 7 days a week, 21 hours a day (3AM – midnight)
<b>Where</b>	Phone service only
<b>Which years</b>	2022 only
<b>How to book</b>	Eligible individuals will receive an invitation by email notification to view in <a href="#">My Account</a> , by mail, or with your T1 paper tax package
